#### SPECIAL PUBLIC MEETING MINUTES

### Roll Call

Dr. Rui Dionisio, Superintendent of Schools; Mr. Thomas Lambe, Business Administrator/Board Secretary, and Mr. Stephen Fogarty, Board Counsel, were also present.

The meeting was called to order by the Board President at 7:05 P.M. Mr. Carolan announced that adequate notice of the meeting has been posted and published as required by law.

Mr. Lambe further stated that the Board shall not be held liable for comments made by members of the public and, in order to protect the privacy

rights of employees in the District, the Board shall not respond to statements made by the public of or about District employees.
